

# DOCUMENTATION

## RISEFR 030-0311

With reference to the national code of building regulations of 27 June 2008 with the Norwegian building regulations of 1 July 2017 and belonging guidance, we document, based on test certificates, evaluations and installation instructions, that this product meets the requirements of the Norwegian authorities as to the fire related qualities.

The documentation is conditional on that the product is in accordance with the specifications given in the appendix and that the product is applied and used in accordance with regulations and all important details in this process follow precisely what is described in an installation manual. Both the installation manual and the RISE Fire Research AS Documentation shall follow the product or be available for the purchaser, user, inspector and the local authority.

The product shall be labeled with **RISEFR 030-0311**, trade name, product responsible and/or manufacturer together with a reference to the production for traceability. The labelling shall have good visibility.

Detailed product design and principle design of installation details are described in "Standard construction details for FB Air Transfer Grilles, belonging to Documentation RISEFR 030-0311". The version of the construction details filed at RISE Fire Research AS at any time is a formal part of the approval.

The product must have at least one annual, external inspection related to the internal system for control of quality. The inspection is adjusted to the type of product and other existing inspection arrangements. Details specified in a written agreement with RISE Fire Research AS.

This documentation was first issued **2023-10-18**. A renewal may be issued based on a written application. Termination by the applicant shall be asked for in writing and with 6 months notice. RISE Fire Research AS may withdraw this documentation when irregularities or misuse happens, and written instructions are not respected.

#### 3. Product description

FB Air Transfer Grilles is a passive vent to be used in fire rated walls. The air transfer grille consists of a casing made by perforated stainless steel sheets. Between the sheets, a layer of intumescent material is applied. The air transfer grille can be made with maximum dimensions 590×590 mm, and with thicknesses 27 mm and 40 mm. The thickness of the intumescent material is 25 mm and 38 mm respectively. Air transfer grille is installed together with louvres.

FB Air Transfer Grilles can be made with an active coating applied on both sides of the perforated steel sheets.

#### 4. Fields of application

FB Air Transfer Grilles is used as vent in fire rated walls.

#### 5. Properties

Table 1 and 2 on the next page show the fire resistance for different designs of FB Air Transfer Grilles with and without louvres. The fire resistance in minutes is evaluated against the criteria with respect to integrity (E) and insulation (I).

FB Air Transfer Grilles with corresponding fire resistance can be used in constructions where the same EI fire resistance is required. I.e., if an air transfer grille has a fire resistance of 30 minutes or more according to Table 1 and 2, it can be used where fire resistance EI 30 is required.

Performance according to EN 1364-5:2017 Annex A is not documented.




Fig.1 FB Air Transfer Grilles.

#### 6. Special conditions for use and installation

FB Air Transfer Grilles shall be installed centric in a gypsum lined aperture in walls with thickness minimum 100 mm. Air transfer grille has fixing brackets on each vertical side, and fire rated sealing compound should be used along the edges. Louvres which cover the aperture should be installed on each side of the wall.

FB Air Transfer Grilles shall be installed according to installation instructions and details shown in "Standard Construction Details for the product, belonging to RISE Fire Research AS documentation RISEFR 030-0311".

Maintenance of FB Air Transfer Grilles is described in information sheet from Securo AS.
